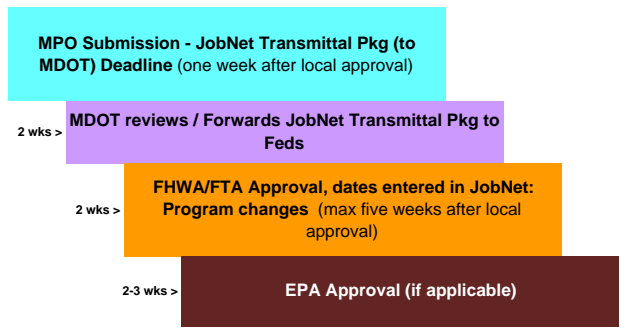

XX	Bi-Monthly TIP Amendments - Policy Committee Action (BCATS Policy Committee typically meets monthly on the 4th Wednesday; scheduled on 3rd Wednesday in July, for staff availability. Above deadline dates backed up 1 week accordingly.)
