EXECUTIVE SUMMARY

As part of its transportation planning process, the Kalamazoo Area Transportation Study (KATS) and the Battle Creek Area Transportation Study (BCATS) completed the transportation conformity process for the KATS 2050 Metropolitan Transportation Plan (MTP), and BCATS 2045 MTP as well as both 2020-2023 Transportation Improvement Programs (TIPs) and relevant portions of the State Transportation Improvement Plan (STIP).

This report documents that the KATS 2050 MTP, BCATS 2045 MTP, and both associated 2020-2023 TIPs, as well as the STIP in Calhoun and Van Buren County meet the federal transportation conformity requirements in 40 CFR Part 93 Subpart A.

Clean Air Act (CAA) section 176(c) (42 U.S.C. 7506(c)) requires federally funded or approved highway and transit activities are consistent with ("conform to") the purpose of the State Implementation Plan (SIP). Conformity to the purpose of the SIP means that transportation activities will not cause or contribute to new air quality violations, worsen existing violations, or delay timely attainment of the relevant national ambient air quality standard (NAAQS) or any interim milestones. 42 U.S.C. 7506(c)(1). United States Environmental Protection Agency's (EPA) transportation conformity rules establish the criteria and procedures for determining whether MTPs, TIPs, and federally supported highway and transit projects conform to the SIP, 40 CFR Parts 51.390 and 93 Subpart A.

On February 16, 2018, the United States Court of Appeals for the District of Columbia Circuit in *South Coast Air Quality Mgmt*. *District v. EPA* (*"South Coast II,"* 882 F.3d 1138) held that transportation conformity determinations must be made in areas that were either nonattainment or maintenance for the 1997 ozone NAAQS and attainment for the 2008 ozone NAAQS when the 1997 ozone NAAQS was revoked. These conformity determinations were required in these areas after February 16, 2019. The Kalamazoo – Battle Creek area (Calhoun, Kalamazoo and Van Buren counties) was in maintenance at the time of the 1997 ozone NAAQS revocation on April 6, 2015 and was also designated attainment for the 2008 ozone NAAQS on May 21, 2012. It was also designated attainment for the 2015 ozone NAAQS on January 16 and August 3, 2018. Therefore, per the *South Coast II* decision, this conformity determination is being made for the 1997 ozone NAAQS on the LRTPs and TIPs.

This conformity determination was completed consistent with CAA requirements, existing associated regulations at 40 CFR Parts 51.390 and 93 Subpart A, and the *South Coast II* decision, according to EPA's *Transportation Conformity Guidance for the South Coast II Court Decision* issued on November 29, 2018.

1.0 BACKGROUND

1.1 TRANSPORTATION CONFORMITY PROCESS

The concept of transportation conformity was introduced in the CAA of 1977, which included a provision to ensure that transportation investments conform to a SIP for meeting the federal air quality standards. Conformity requirements were made substantially more rigorous in the CAA Amendments of 1990. The transportation conformity regulations that detail implementation of the CAA requirements was first issued in November 1993 and have been amended several times. The regulations establish the criteria and procedures for transportation agencies to demonstrate that air pollutant emissions from LRTPs, TIPs, and projects are consistent with ("conform to") the state's air quality goals in the SIP. This document has been prepared for state and local officials who are involved in decision-making on transportation investments.

Transportation conformity is required under CAA Section 176(c) to ensure that federally supported transportation activities are consistent with ("conform to") the purpose of a state's SIP. Transportation conformity establishes the framework for improving air quality to protect public health and the environment. Conformity to the purpose of the SIP means Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) funding and approvals are given to highway and transit activities that will not cause new air quality violations, worsen existing air quality violations, or delay timely attainment of the relevant air quality standard, or any interim milestone.

1.2 CONFORMITY AREA

The conformity area consists of three counties: Calhoun, Kalamazoo and Van Buren. Within the boundary are the metropolitan planning organizations (MPOs) of KATS and BCATS as well as the rural projects contained in the STIP in Calhoun and Van Buren County.

Findings of the transportation conformity report are for transportation activities contained within the conformity area.

1.3 ATTAINMENT STATUS

On April 15, 2004, the EPA issued final designations of areas not attaining the 1997 ozone NAAQS. Calhoun, Kalamazoo and Van Buren counties were designated a nonattainment area.

On May 16, 2007, the EPA redesignated the area attainment, approving and finding adequate motor vehicle emissions budgets for volatile organic compounds (VOC) and nitrogen oxides (NOx) for the year 2018. The area was placed into maintenance; this requires conformity emissions to be compared to the motor vehicle emission budgets contained in the SIP.

On July 20, 2012, the EPA designated all of Michigan as attainment for the strengthened 2008 ozone NAAQS.

On July 20, 2013, the EPA partially revoked the 1997 ozone NAAQS, revoking the requirement to do transportation conformity for areas that were in maintenance.

On April 6, 2015, the EPA completely revoked the 1997 ozone NAAQS, which resulted in removal of all transportation conformity requirements.

On April 23, 2018, FHWA began requiring areas in the country to conduct conformity if they were a maintenance area for the 1997

ozone NAAQS and attainment for the 2008 ozone NAAQS when the 1997 ozone NAAQS was revoked. This was to comply with the court's decision in *South Coast II*. The Kalamazoo – Battle Creek conformity area was one of these areas. Later, this was amended to require MPOs to have a conformity in place on February 16, 2019 and conduct conformity going forward.

Calhoun County was designated Jan. 16. 2018 as attainment for the 2015 ozone standard. On August 3, 2018, the EPA designated both Kalamazoo and Van Buren counties as attainment for the strengthened 2015 ozone NAAQS.

On December 4, 2019, the EPA proposed a rule that the Kalamazoo – Battle Creek 1997 ozone maintenance area be considered for a limited maintenance plan for the area's second maintenance period. To be considered for a limited maintenance plan, the area must show the design value to be well below the NAAQS and the area's levels of air quality are unlikely to violate the NAAQS in the future. Areas with limited maintenance plans are not required to conduct emission modeling for conformity.

On April 6, 2020, the limited (second) maintenance plan for the Kalamazoo – Battle Creek 1997 ozone NAAQS took effect (85 FR 13057.)

2.0 LONG-RANGE TRANSPORTATION PLAN OR METROPOLITAN TRANSPORTATION PLAN

The Long-Range Transportation Plan (LRTP), also referred to as a MTP, is developed by the MPO to establish a long-term transportation plan. An LRTP is federally required for MPOs to receive federal funding and must provide a 20-year (or longer) horizon. Plans are required to be updated every four to five years. The purpose of an LRTP is to assess future needs of the area's transportation system and set goals to meet those needs. The planning process can enhance quality of life by fostering the mobility of people and freight in an effective and safe method.

Findings of the transportation conformity report are for transportation activities contained within the conformity area. The KATS and BCATS are developing new 2050 and 2045 LRTPs. This conformity report is to ensure that the LRTPs in the Kalamazoo – Battle Creek maintenance area satisfies their obligation to the CAA. This analysis also includes all three areas' S/TIPs and their latest amendments. This report evaluates transportation activities contained in:

- KATS 2050 MTP,
- KATS 2020-2023 TIP,
- BCATS 2045 MTP,
- BCATS 2020-2023 TIP, and
- STIP projects in Calhoun and Van Buren County.

3.0 TRANSPORTATION IMPROVEMENT PROGRAM

The TIP is a financially constrained four-year program covering the most immediate implementation priorities for transportation projects and strategies from the LRTP.

The TIP identifies proposed projects developed by local agencies in accordance with the joint regulations of the FHWA and the FTA. These regulations establish the TIP as the programming phase of the overall continuing, comprehensive, and cooperative planning process. This planning process includes local jurisdictions, transit agencies, and state and federal transportation officials.

All areas in Michigan are operating under 2020-2023 TIPs that were approved for use by FHWA and FTA on Oct. 1, 2019. Conformity for the Kalamazoo – Battle Creek maintenance area was conducted on the 2017-2020 TIPs and associated LTRPs, and received a letter supporting the conformity findings from FHWA/FTA on May 30, 2019. A new conformity was not done for the 2020-2023 TIP since no new non-exempt projects were part of the new TIP.

4.0 TRANSPORTATION CONFORMITY DETERMINATION: GENERAL PROCESS

Per the court's decision in *South Coast II*, beginning February 16, 2019, a transportation conformity determination for the 1997 ozone NAAQS will be needed in 1997 ozone NAAQS nonattainment and maintenance areas identified by EPA¹ for certain transportation activities, including updated or amended MTPs and TIPs. FHWA/FTA made its 1997 ozone NAAQS conformity determination for the 2040 LRTPs and 2017 -2020 TIPs on May 30, 2019. Conformity will now be required no less frequently than every four years. This conformity determination report will address transportation conformity for the new KATS 2050 MTP, including the BCATS 2045 MTP and the 2020-2023 S/TIPs.

5.0 TRANSPORTATION CONFORMITY REQUIREMENTS

5.1 OVERVIEW

On November 29, 2018, EPA issued the **Transportation Conformity Guidance for the South Coast II Court Decision**² (EPA-420-B-18-050, November 2018) that addresses how transportation conformity determinations can be made in areas that were nonattainment or maintenance for the 1997 ozone NAAQS when the 1997 ozone NAAQS was revoked but were designated attainment for the 2008 ozone NAAQS in EPA's original designations for this NAAQS (May 21, 2012). The area was designated attainment for the 2008 ozone NAAQS on May 21, 2012, and January 16 and August 3, 2018, for the 2015 ozone NAAQS.

The transportation conformity regulation at 40 CFR 93.109 sets forth the criteria and procedures for determining conformity. The conformity criteria for MTPs and TIPs includes: latest planning assumptions (93.110), latest emissions model (93.111), consultation (93.112), transportation control measures (93.113(b) and (c)), and emissions budget and/or interim emissions (93.118 and/or 93.119).

For the 1997 ozone NAAQS areas, transportation conformity for MTPs and TIPs for the 1997 ozone NAAQS can be demonstrated without a regional emissions analysis, per 40 CFR 93.109(c). This provision states that the regional emissions analysis requirement applies one year after the effective date of EPA's nonattainment designation for an NAAQS and until the effective date of revocation of such NAAQS for an area. The 1997 ozone NAAQS revocation was effective on April 6, 2015, and the *South Coast II* court upheld the revocation. As no regional emission analysis is required for this conformity determination, there is no requirement to use the latest emissions model, or budget or interim emissions tests.

Therefore, transportation conformity for the 1997 ozone NAAQS for the KATS 2050 MTP, BCATS 2045 MTP, both 2020-2023 TIPs, and the rural STIP in Calhoun and Van Buren County can be demonstrated by showing the remaining requirements in Table 1 in 40 CFR 93.109 have been met. These requirements, which are laid out in Section 2.4 of EPA's guidance and addressed below, include:

- Latest planning assumptions (93.110),
- Consultation (93.112),
- Transportation Control Measures (93.113), and
- Fiscal constraint (93.108).

5.2 LATEST PLANNING ASSUMPTIONS

The use of latest planning assumptions in 40 CFR 93.110 of the conformity rule generally apply to regional emissions analysis. In the 1997 ozone NAAQS areas, the use of the latest planning assumptions requirement applies to assumptions about transportation control measures (TCMs) in an approved SIP.

The Michigan SIP does not include any TCMs (see also Section 5.4).

5.3 CONSULTATION REQUIREMENTS

The consultation requirements in 40 CFR 93.112 were addressed both for interagency consultation and public consultation.

Interagency consultation was conducted with KATS, BCATS, the Michigan Department of Transportation (MDOT), the Michigan Department of Environment, Great Lakes, and Energy (EGLE), FHWA, FTA, and EPA. A summary of the Michigan Transportation Interagency Workgroup (MITC-IAWG) meeting on September 15, 2021, and relevant interagency consultation correspondence related to this conformity is in Appendix A. Interagency consultation was conducted consistent with Michigan's conformity SIP.

Public consultation was conducted consistent with planning rule requirements in 23 CFR 450. The Public Participation Plan adopted by the MPO Policy Committee establishes the procedures by which the MPOs reach affected public agencies and the public. The same procedures were followed for this document, ensuring the public has an opportunity to review and comment before the MPOs make a determination.

A formal public comment period for this draft conformity report was held from September 29, 2021 to November 24, 2021, for KATS and from February 7, 2022 to February 23, 2022, for BCATS. Public comments received and responses to those comments are in Appendix B. The KATS policy committee made a formal conformity determination through a resolution on November 24, 2021.

The BCATS policy committee made a formal conformity determination through a resolution on February 23, 2022.

5.4 TIMELY IMPLEMENTATION OF TRANSPORTATION CONTROL MEASURES

The Michigan SIP does not include any TCMs.

5.5 FISCAL CONSTRAINT

Transportation conformity requirements in 40 CFR 93.108 state that transportation plans and TIPs must be fiscally constrained consistent with the metropolitan planning regulations at 23 CFR part 450. The LRTPs and 2020-2023 TIPs are fiscally constrained, as demonstrated in:

- BCATS 2045 MTP, Chapter 15 Financial Plan,
- BCATS 2020-2023 TIP, Financial Plan as updated to include the most current amendment,
- KATS 2050 MTP, Chapter 10 Moving Forward,
- KATS 2020-2023 TIP, Financial Plan as updated to include the most current amendment, and
- 2020-2023 STIP, including latest amendments for Calhoun and Van Buren County.

6.0 CONCLUSION

The conformity determination process completed for the KATS 2050 MTP, BCATS 2045 MTP, both 2020-2023 TIPs, and the 2020-2023 STIP for Calhoun and Van Buren County demonstrates that these planning documents meet the CAA and Transportation Conformity rule requirements for the 1997 ozone NAAQS.

Attendance at the meeting was by teleconferencing only.

Both MPOs in the Kalamazoo – Battle Creek 1997 Ozone Orphan Maintenance Area are developing new 2045 and 2050 long-range transportation plans (LRTP). Projects for each area were provided in advance of the meeting.

First discussed were projects for KATS new 2050 Metropolitan Transportation Plan, also referred to as a LRTP. See list in Appendix C.

Donna Wittl was the representative for the rural Statewide Transportation Improvement

Program (STIP). All projects were deemed exempt. Projects are included in Appendix C.

The BCATS 2045 LRTP projects were reviewed. All projects were deemed exempt. See list in Appendix C.

It was noted that the KATS and BCATS list would need to be finalized with each project classified as exempt or non-exempt. Both MPOs were still working on exact project for fiscal constraint of the LRTPs.

The group was asked if they had any questions on the policies for reviewing projects. Questions were asked and the group agreed to the policies. The policies were sent again to the MITC-IAWG after the meeting to ensure all partners had copies.

MITC-IAWG Policies for Reviewing Projects for

Kalamazoo-Battle Creek Limited Orphan Maintenance Area (Kalamazoo, Calhoun, and Van Buren Counties)

Policies were reviewed and agreed to by the Michigan Transportation Conformity Interagency Workgroup (MITC-IAWG) for the above areas at the September 15, 2021 meeting.

The Transportation Conformity State Implementation Plan Memorandum of Agreement defines roles, responsibilities, and regulations for interagency workgroups in Michigan.

General Policies:

1. Definition of an air quality regionally significant project:

A transportation project on a facility that serves regional transportation needs (access to and from the areas) from outside the region, access to major activity centers (and new centers of activity malls, sporting, and transportation terminals), <u>and</u> would normally be included in the travel demand model. <u>At a minimum</u>, includes principal arterials (national functional classification 1, 2, and 3) and fixed guideway transit that offer an alternative to regional highway travel.

2. Traffic circles and roundabouts: exempt; intersection channelization project.

3. Auxiliary lanes if 1 mile or less: exempt; projects that correct, improve, or eliminate a hazardous location or feature. EPA/FHWA policy November 2017.

4. Ramp metering: exempt; projects that correct, improve, or eliminate a hazardous location or feature. EPA/FHWA policy November 2017.

5. Addition of right-turn lane or left-turn lane at an intersection, individual lane length less than half a mile: exempt; projects that correct, improve, or eliminate a hazardous feature; or not able to be modeled with the travel demand model.

6. Adding a center turn lane of 1 mile or less: exempt; projects that correct, improve, or eliminate a hazardous feature.

7. Adding a thru lane of less than half a mile: exempt; projects that correct, improve, or eliminate a hazardous feature.

8. Road diets:

a. Four to three lanes: four through-lanes <u>to</u> two through-lanes with dual center left-turn lane if length is 1 mile or less: exempt; projects that correct, improve, or eliminate a hazardous location or feature.

b. Other types of road diets must provide information on the Road Diet Questionnaire to be considered for exempt status. If information is not provided road diet will be considered non-exempt.

i.Road diet questionnaire process:

- 1. Road Diet Questionnaire will be filled out either by local road agency or MPO staff.
- 2. The road diet will be identified in project list and the road diet questionnaire sent to the MITC-IAWG.
- 3. MITC-IAWG members reply via email if they consider the project exempt.
- 4. If no objection to the project as exempt is received, no further action is required.
- 5. If a member believes the project is non-exempt, a conference call will be held to discuss the project.

9. For amendments to only change the cost of a project or projects, the previous air quality status (exempt or non-exempt) will remain for each project. The MITC-IAWG will not need to review the project again. The MPO for TIP projects and MDOT for rural STIP projects will be responsible for ensuring that only cost changed. A statement attached to the amendment when submitted will state only costs have changed. The statement will also list when the last time each project was reviewed by the MITC-IAWG.

10. Projects included in a General Project Account (GPA) have to be exempt. GPAs should be reviewed by MITC-IAWG to confirm exempt status.

Specific Policies:

Nonattainment Areas:

1. If a non-exempt project is part of an amendment, a conference call MITC-IAWG is required.

- 2. If all projects in the amendment are exempt, an MITC-IAWG can be conducted by e-mail.
 - a. Process to conduct a MITC-IAWG through e-mail:
- i. The MPO will e-mail the IAWG requesting concurrence that all projects are exempt.
- ii.The list of projects is attached to the email. Spreadsheet should include fields required for MITC-IAWG review.
- iii.The IAWG members will have five business days, starting the day after the e-mail project list is sent to review. IAWG members are requested to respond "concur" or "do not concur." Only one response from each member agency of the IAWG is required. Other are encouraged to respond since they have knowledge that is important to the group.
- iv. The date of the IAWG will be the date the e-mail request is sent.
- v.The meeting summary will be sent to the MITC-IAWG. A basic e-mail format has been established.
 - 3. Projects are grouped into analysis years based on the year the project will be open to traffic.

4. Moving a non-exempt project within an analysis year group can be done as part of an e-mail IAWG. The situation should be explained in the air quality comment field.

5. All projects that <u>can be modeled</u> in the travel demand model will be modeled regardless of exempt status when a new conformity analysis is conducted.

Limited Orphan Maintenance Area (LOMA) or Orphan Maintenance Area (OMA):

- 1. All MITC-IAWGs can be conducted by e-mail.
- 2. Process to conduct a MITC-IAWG through e-mail:
 - 1. The MPO will e-mail the IAWG requesting concurrence of projects for TIP and MDOT will email for rural STIP.
 - 2. The list of projects for review should be attached in a spreadsheet which includes fields needed by the MITC-IAWG to make decisions.
 - 3. The IAWG members will have five business days, starting the day after the e-mail project list is sent to review. IAWG members are requested to respond "concur" or "do not concur." Only one response from each member agency of the IAWG is required. Other are encouraged to respond since they have knowledge that is important to the group.
 - 4. The date of the IAWG will be the date the e-mail request is sent.
 - 5. A meeting summary will to be sent to the MITC-IAWG.
 - 6. If an amendment contains a non-exempt project a new conformity report will be needed.

APPROVAL OF THE AGENDA

MOTION by Heppler, SECOND by Drouin, "to approve the agenda of the December 15, 2021 Policy Committee Meeting." MOTION APPROVED.

PUBLIC COMMENTS

Selden of Bike Friendly Kalamazoo announced the Community-Wide Bicycle Program Steering Committee met December 1, 2021. The national bicycle skills "All Kids Bike Program" will be presented to every Kindergarten Physical Education class in the region. Sawyer Duncan, Vicksburg School District Physical Education Teacher, will lead the curriculum.

CONSENT AGENDA

-ACCEPTANCE OF THE TREASURER'S REPORT -ACCEPTANCE OF THE TECHNICAL COMMITTEE REPORT (DECEMBER 2, 2021) -ACCEPTANCE OF THE SOUTHCENTRAL MICHIGAN PLANNING COUNCIL REPORT -APPROVAL OF THE MINUTES FROM THE NOVEMBER 17, 2021 MEETING

MOTION by Johnson, SECOND by Heppler, "to accept and approve the items on the Consent Agenda." MOTION APPROVED.

TRANSPORTATION IMPROVEMENT PROGRAM AMENDMENTS

Stepek provided information on the five amendments included in the packet. Three are additions related to 2023 safety grants that were awarded and two are budget increases. The Technical Committee recommends approval of the Transportation Improvement Program Amendments as presented.

MOTION by Drouin, SECOND by Britigan, *"to approve the Fiscal Year 2020 – 2023 Transportation Improvement Program Amendments."* MOTION APPROVED.

STATE SAFETY TARGETS

The State Safety Targets, data, and supporting documentation is included in the meeting packet. Stepek elaborated that this is the annual state's 2022 calendar year target. Per Federal requirements, every Metropolitan Planning Organization is required to either adopt the state safety targets or develop their own. Kalamazoo Area Transportation Study has traditionally supported state targets. Region-wide data shows an overall downward trend for bicyclist and pedestrian serious injuries, serious injuries, and fatalities with some exceptions. The Technical Committee recommends supporting the State Safety Targets as presented.

Olson asked when the US-131 project was set to begin. DenBraber responded it is moved from 2023 to 2024.

Johnson added the Road Commission of Kalamazoo County analyzes data to support the type of safety project improvements they pursue. The region is trending in a positive direction as the Road Commission continues correction and support to reduce accidents and fatalities in funded projects.

MOTION by Heppler, SECOND by Janssen, *"to approve the State Safety Targets."* MOTION APPROVED.

LOMA OZONE CONFORMITY REPORT

The report is included in the meeting packet. Stepek explained this is the first time Kalamazoo Area Transportation Study (KATS) along with Battle Creek Area Transportation Study (BCATS) are considered a Limited Orphan Maintenance Area (LOMA) for ozone conformity. Conformity is based on fiscal constraint. KATS Staff and the Technical Committee recommend approval of the report and submission with the Metropolitan Transportation Plan to the Michigan Department of Transportation.

MOTION by Johnson, SECOND by Janssen, *"to approve the LOMA Ozone Conformity Report."* MOTION APPROVED.

POLICY COMMITTEE OFFICER ELECTIONS

Drouin and Sorensen served on the Officer Nomination Subcommittee. Drouin reported nominations for the two-year terms beginning January 1, 2022 include renewed terms for both Chair and Vice-Chair, Randy Thompson (Comstock Township) and Libby Heiny-Cogswell (Oshtemo Township), respectively. Rob Britigan (City of Parchment), is nominated for Treasurer. Thompson thanked Drouin for serving as Treasurer.

MOTION by Janssen, SECOND by Johnson, *"to approve the Nomination Subcommittee recommendations for Policy Committee Officers as: Randy Thompson-Chair, Libby Heiny-Cogswell-Vice-Chair and Rob Britigan-Treasurer."* MOTION APPROVED.

PROJECT LIST FOR 2024 – 2026 TRANSPORTATION IMPROVEMENT PROGRAM

Stepek explained this full project list is included in the packet and available on the katsmpo.org website with a map. Although Kalamazoo Area Transportation Study (KATS) Staff has prioritized the list, prioritization is not shared so it does not impact public opinion. The prioritization process will be communicated in January 2022, the project draft list will be ready in February 2022 with the document presented in March 2022. Britigan asked if the list included only those projects reviewed or all the projects submitted. Stepek answered it includes all projects that were submitted. If any project is missing, let KATS know.

PUBLIC TRANSPORTATION UPDATES

Janssen reported the Kalamazoo County Transportation Authority (KCTA)/ Central County Transportation Authority (CCTA) board met December 13, 2022 to discuss the tragic shooting incident that occurred throughout the Kalamazoo Transportation Center Area on November 27, 2021. The weight of the incident was expressed during the meeting. Security plans in place were discussed. The meeting brought attention to the severe trauma experienced by victims, witnesses, and staff. Some bus drivers have quit making the bus driver shortage worse. Overall, bus drivers responded appropriately by closing bus doors and having riders duck to the floor. One bus driver transported a victim to the hospital in a bus. Metro's national union brought in grief counselors. Earl Cox, President of the Amalgamated Transit Union contacted a Chaplain who was onsite within 15 minutes to assist with shock and fear. Sympathies go out to the shooter who was a troubled individual as well as his family who is also challenged by the event. The shooter was killed by Kalamazoo Public Safety who arrived at the scene within 2 minutes. In the aftermath of the incident, Metro is forming a task force to develop both short-term and long-term plans moving forward. Drouin asked if Metro Connect services Mattawan and Paw Paw. Henderson responded Van Buren Public Transit services Paw Paw. Call them to schedule pick-up and drop-off. Transit Authorities cross over county boarders for legal and medical reasons with service to the Battle Creek Veteran's Administration Hospital on Tuesdays and Thursdays.

EXECUTIVE DIRECTOR'S REPORT

Stepek elaborated in addition to the memo included in the meeting materials, Fiscal Year 2021 Obligated Project Report and Fiscal Year 2021 Transportation Improvement Program Modification Summary reports are available on the katsmpo.org website. Invitations will be forthcoming for KATS 101 Training and Timesheet Training which will be held via Zoom in January 2022. The KATS fiscal year-end 2021 financial audit is complete.

NEW BUSINESS

No new business was brought forth.

PUBLIC COMMENTS

Selden of Bike Friendly Kalamazoo invited attendees to Bike Week May 7, 2022 – May 14, 2022. Kalamazoo Bicycle Club will host its annual presentation of Bike Camp. Results of the bike and pedestrian safety enforcement program conducted by the Office of Highway Safety and Planning and the Michigan State Police were presented at the community-wide Bike Program Steering Committee meeting held on December 1, 2021. Citations and warnings were issued to both motorists and bicyclists for violation of traffic laws. The successful program will be repeated. Selden thanked KATS Staff, the Policy Committee, and Technical Committee for advances in non-motorized progress over the past year.

MEMBER COMMENTS

Britigan representing the City of Parchment thanked members for the nomination as Policy Committee Treasurer, accepts the nomination, and looks forward to the role.

Herringa reported Portage Road in the City of Portage will be closed the weekend of December 18, 2021 for a temporary pedestrian bridge installation over Portage Road so workers can traverse from the parking area to Pfizer's expansion project.

Heiny-Cogswell thanked members for the Vice-Chair appointment. Oshtemo Township has been significantly impacted by the COVID pandemic this week as two staff members tested positive, a family member of an employee died recently due to complications from the virus, and two other employee family members are severely ill with COVID. Oshtemo Township will again require masks in offices and are expected to close township customer service next week due to insufficient staffing.

Heppler announced that after several years of trying, the Michigan Department of Transportation (MDOT) awarded the Village of Augusta an \$830,000 grant to replace the Washington Street bridge in 2024. Heppler appreciates partnership with MDOT, the Road Commission of Kalamazoo County, and area townships. The village 5-year rolling road replacement plan is being reviewed including plans to replaced Augusta Drive. Related to Selden's comments on bicyclist and motorist traffic violation enforcement, Heppler stated the importance of enforcement, engineering, and education.

Olson stated the Village of Vicksburg Christmas parade was a success. The downtown project is almost done. Roads are open. Street lights are being installed and traffic lights should be back up near the first of the year.

Joshi appreciates assistance from everyone as her first year as the City of Galesburg City Manager is wrapping up.

Johnson reported the Road Commission of Kalamazoo County (RCKC) was busy with cleanup after recent damaging strong winds. Johnson gave a shout-out to all first responders that assisted including firefighters, law enforcement, and 911 central dispatch. RCKC is proud and appreciative to be a recipient of the 2021 Branch Award from the American Public Works Association for the Sprinkle Road project.

Thompson thanked members for another term as Chair and thanked Britigan for accepting the Treasurer nomination.

Resolution to Accept the Transportation Conformity Determination Report for the 1997 Ozone NAAQS for the Kalamazoo-Battle Creek Limited Orphan Maintenance Area for the Battle Creek Area Transportation Study

WHEREAS, per the decision in South Coast II, beginning February 16, 2019, transportation conformity determinations for the 1997 ozone national ambient air quality standard (NAAQS) will be needed for those areas that were maintenance areas when the 1997 ozone NAAQS was revoked and then attainment for the 2008 and 2015 NAAQSs, referred to as "orphan" areas; and

WHEREAS, in November 2018, the United States Environmental Protection Agency (EPA) promulgated guidance to assist in implementing the court decision in South Coast II, providing the requirements to demonstrate transportation conformity for areas that were "orphan" areas; and

WHEREAS, the EPA designated the Kalamazoo-Battle Creek non-attainment area of Kalamazoo, Calhoun and Van Buren counties as a maintenance area for the 1997 ozone NAAQS in May 2007 and attainment in July 2012 for the stricter 2008 ozone NAAQS and in January 2018 for the 2015 ozone NAAQS and in April 2020 created a limited second maintenance plan for the 1997 ozone NAAQS; and

WHEREAS, the Kalamazoo-Battle Creek MI maintenance area is deemed an "orphan" area, and the Battle Creek Area Transportation Study (BCATS) is wholly contained in the Kalamazoo-Battle Creek limited orphan maintenance area; and

WHEREAS, the Battle Creek Area Transportation Study (BCATS) is the designated Policy Committee and Metropolitan Planning Organization for the Battle Creek, Michigan urban area; and

WHEREAS, the conformity of BCATS' 2045 Metropolitan Transportation Plan, including the FY 2020-2023 Transportation Improvement Program (TIP), will be pending approval by the Federal Highway Administration after local action on the conformity report by the Battle Creek Area Transportation Study;

NOW THEREFORE BE IT RESOLVED, that the Policy Committee of the Battle Creek Area Transportation Study accepts the conclusions of the Transportation Conformity Determination Report for the 1997 Ozone NAAQS for the Kalamazoo-Battle Creek limited orphan maintenance area for the BCATS 2045 Metropolitan Transportation Plan and the 2020-2023 Transportation Improvement Program; and

BE IT FURTHER RESOLVED, that the Transportation Conformity Determination Report for the 1997 Ozone NAAQS for the Kalamazoo-Battle Creek limited orphan maintenance area demonstrates that these planning documents meet the Clean Air Act and Transportation Conformity rule requirements for the 1997 ozone NAAQS to conform to the State Implementation Plan as required by provisons of Title 40 CFR 51.390 and 93 Subpart A, and the South Coast II decision.
